

TAILS A WAGG'N PET RESORT

Boarding Agreement

I, the Pet Owner agree to pay the rate for the pet care provided in effect on the date the pet is checked into Tails A Wagg'n Pet Resort. That also includes all cost and charges for any special services I request during that time. If my pet causes any damages to the contents in the room or the room itself, I will pay to have them either replaced or fixed. The cost will be assessed by the facility.

I further agree that the pet will not leave the facility until all charges due are paid in full or both parties agree upon proper payment arrangements.

I, the Pet Owner, authorize Tails A Wagg'n Pet Resort to provide pet care services for my pet. My pet is current on all vaccinations and has not been exposed to or had any communicable sickness in the past 30 days. Also my pet does not have any open wounds and/or stitches. If your pet has been sick they must be symptom free for a minimum of 10 days or have written letter from veterinary before check in.

I understand that having my pet in the company and environment of other pets may involve risks regarding the contraction of illness or disease (Kennel Cough, Fleas, etc.) I understand that even regular vaccinations or preventatives cannot completely guard against illness and disease and that Tails A Wagg'n Pet Resort cannot in any form prevent or be responsible for any illness that my pet might contract. If fleas are found on your pet during their stay you will be charged a \$25.00 fee for treatment.

If my pet becomes ill or injured, or if the state of the animals health otherwise requires professional attention, Tails A Wagg'n Pet Resort, in its sole discretion, may engage the services of a veterinarian, administer medicine or give other requisite attention to the animal, and the expense thereof shall be paid by the Pet Owner as noted on release form.

I understand that there are risks in having my pet boarded in an environment where my pet is around other pets. If interactive activity is offered, I understand and accept potential risks that could be involved. I acknowledge that Tails A Wagg'n Pet Resort, its employees, or volunteers will take such action as are reasonable to minimize these risks. I will be solely responsible for any actions my pet causes while in the care of pet provider, to include payment of costs for damages or injury to other pet friends, people, or objects in the care of Tails A Wagg'n Pet Resort.

I have fully disclosed to Tails A Wagg'n Pet Resort any history my pet may have of aggression, biting, or causing other injury or damage to people, other animals or property, and I understand that Tails A Wagg'n Pet Resort has the right to refuse services as a result thereof. Pet Owner will be liable for any medical care expenses and damages that result from an animal bite. I further understand and agree that Tails A Wagg'n Pet Resort or their employees will not be liable for any kind of problems that arise from my pets stay.

I understand and agree that if I do not pick up my pet on the scheduled day of pick up, then I hereby authorize Tails A Wagg'n Pet Resort to take whatever action to continue care for my pet and I agree to pay all costs of continuing such care upon demand of Tails A Wagg'n Pet Resort. Further, if I do not pick up my pet within 5 days of scheduled date, Tails A Wagg'n Pet Resort will send certified letter to last known address that the pet will become property of Tails A Wagg'n Pet Resort within 15 days of dated letter. After those 15 days the pet will be considered unwanted and will become property of Tails A Wagg'n Pet Resort and your rights as an owner are revoked.

I understand and agree that each and every of the foregoing provisions containing in all paragraphs above shall be in force and effect and shall apply to each and every occasion on which I board and that this Agreement shall remain in full force between parties until cancelled or superceded by a writing signed by both parties.

My signature on this Agreement indicates that I hereby certify that I have read and understand these rules and regulations set forth above in this Agreement and each of its terms and conditions and agree to abide and be bound by these rules and regulations.
